About Congressman John Campbell

A champion of civil justice reform and the former target of baseless litigation, **Congressman John Campbell** will discuss his experiences in Washington. He is a businessman whose car dealership was frivolously sued for having gasoline on the premises. While in the California Legislature, he opposed the "Sue Your Boss" legislation, and he now says Congress is even loonier than Sacramento. Congressman Campbell offers his thoughts on the status of tort reform in Congress and about the influence of the plaintiffs' bar on Federal legislation. He will comment on the recent proposed tax break for trial attorneys to deduct upfront expenses in contingency fee cases that was buried in a tax increase bill. On taxes and spending, Congressman Campbell is a vocal reformer and is also outspoken on his favorite topic: "Earmarks." He will also provide his perspective on the Presidential election.
